## 2. INVESTMENT

In 2012, the Hong Kong is sixth in the list of foreign investors in Vietnam with a total of 43 new projects approved, 16 projects increase capital, the total number of new and increase capital is 657,63 million USD. Cumulatively, until 12/2012, Hong Kong's total investment in Vietnam is 699 projects with a total capital of \$ 3.8 billion USD and the total registered investment capital of 11.9 billion USD.

Hong Kong's investment projects in Vietnam, mainly in the textile industry, fisheries, electricity, electronics, petrochemical and real estate projects.
